ORDINANCE NO 12-22

AN ORDINANCE TO AWARD THE CONTRACT FOR RESIDENTIAL CURBSIDE TRASH HAULING IN THE VILLAGE OF HEBRON TO ADKINS DISPOSAL SERVICE AND TO AUTHORIZE AND DIRECT THE MAYOR AND FISCAL OFFICER TO ENTER INTO AN AGREEMENT FOR SUCH SERVICE.

WHEREAS, The Village of Hebron advertised for bids for curbside residential trash hauling for a contract period beginning July 1, 2022 and ending June 30, 2025, and;

WHEREAS, two bids for such service were received, and;

WHEREAS the municipal staff of the Village of Hebron reviewed and evaluated the bids received, and;

WHEREAS, Adkins Disposal Service submitted the lowest and best bid,

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF HEBRON, STATE OF OHIO, AND THE MAJORITY OF THE MEMBERS ELECTED THERETO CONCURRING THAT:

Section I: The Council of Hebron, Ohio hereby awards the contract for curbside residential trash hauling to Adkins Disposal Service, beginning July 1, 2022 and ending June 30, 2025.

Section II: The Mayor and Fiscal Officer be and hereby are authorized and directed on behalf of the Village of Hebron, to enter into an agreement therefore with Adkins Disposal Service, a copy of which is attached hereto and made a part hereof and marked Exhibit "A".

Section III: This ordinance shall take effect and be in full force at the earliest date allowed by law.

Ordinance # 12-22

CONTRACT

This contract is made this 27th day of July, 2022, by and between the Village of Hebron, Licking County, Ohio and Adkins Disposal Service hereinafter referred to as the Contractor.

WITNESSETH:

The contractor hereby agrees to furnish at Contractor's own cost and expense all equipment, labor and materials for the collection, transportation and disposal of garbage, refuse, trash and yard waste of residential householders according to Advertisement (Notice to Bidders), Information for Bidders, Specifications, Proposal, Proposal Bond, Contract and Contract Bond (the "Contract Documents") therefore, which are on file in the Village of Hebron offices and which are by reference made a part of this contract and attached hereto.

All of the equipment, labor and materials shall be furnished according to the Contract Documents and to the satisfaction of the Village of Hebron at the price set forth in the accompanying proposal, which is made a part of this contract.

The Village of Hebron, in consideration of the full and faithful performance of the provisions herein, agrees that it will grant to the Contractor the exclusive right to collect garbage, trash, refuse and yard waste from residential households in the incorporated area of the Village of Hebron for a period from:



July 1st, 2022 - June 30th, 2025

It is mutually agreed that the Village of Hebron shall have the power of termination of this contract if the Contractor fails to comply with the provisions outlined in the Contract Documents. If the Village of Hebron determined that the Contractor is not complying with the terms of the Contract Documents, it may terminate the contract by giving the Contractor thirty (30) days certified mail notice.

The Village of Hebron, its successors and assigns, and the Contractor for themselves, their successors, executors, administrators and assigns, have bound themselves to their part of this agreement. Neither the Village of Hebron nor the Contractor shall assign, submit or transfer its interest in this agreement without the written consent of the parties hereto.
