ORDINANCE 13-24

AN ORDINANCE TO ESTABLISH TWO HOUR PARKING UPON A SECTION OF EAST MAIN STREET AND TO ERECT SIGNAGE FOR THE SAME PURPOSE

WHEREAS, Section 4511.07(A)(1) authorizes local municipalities to regulate local streets and highways under their jurisdiction as long as said regulations are within the reasonable exercise of police power; and,

WHEREAS, to ensure that parking in the vicinity of East Main Street is available for customers of businesses within the Village, it is the will of the Council of the Village of Hebron that the parking along East Main Street, more specifically detailed in the map attached Exhibit A and herein incorporated by reference, should be limited to two-hour parking; and,

NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE OF HEBRON, COUNTY OF LICKING, AND STATE OF OHIO, WITH A MAJORITY OF THE MEMBERS CONCURRING THERETO THAT:

Section I: Council for the Village of Hebron, Ohio does hereby establish and ordain two-hour parking regulations on a portion of East Main Street more specifically detailed in the map attached Exhibit A.

Section II: Village Council authorizes the Public Works Department to install two-hour parking signage on certain portions of East Main Street, and that said regulations should be enforced by the Village Police Department, or any other law enforcement agency as more specifically detailed in the proposed codified code section attached Exhibit B which is herein incorporated by reference.

Section III: This Codified Ordinance section stated more specifically in the attached Exhibit B shall take effect and be in full force upon the earliest period allowed by law.

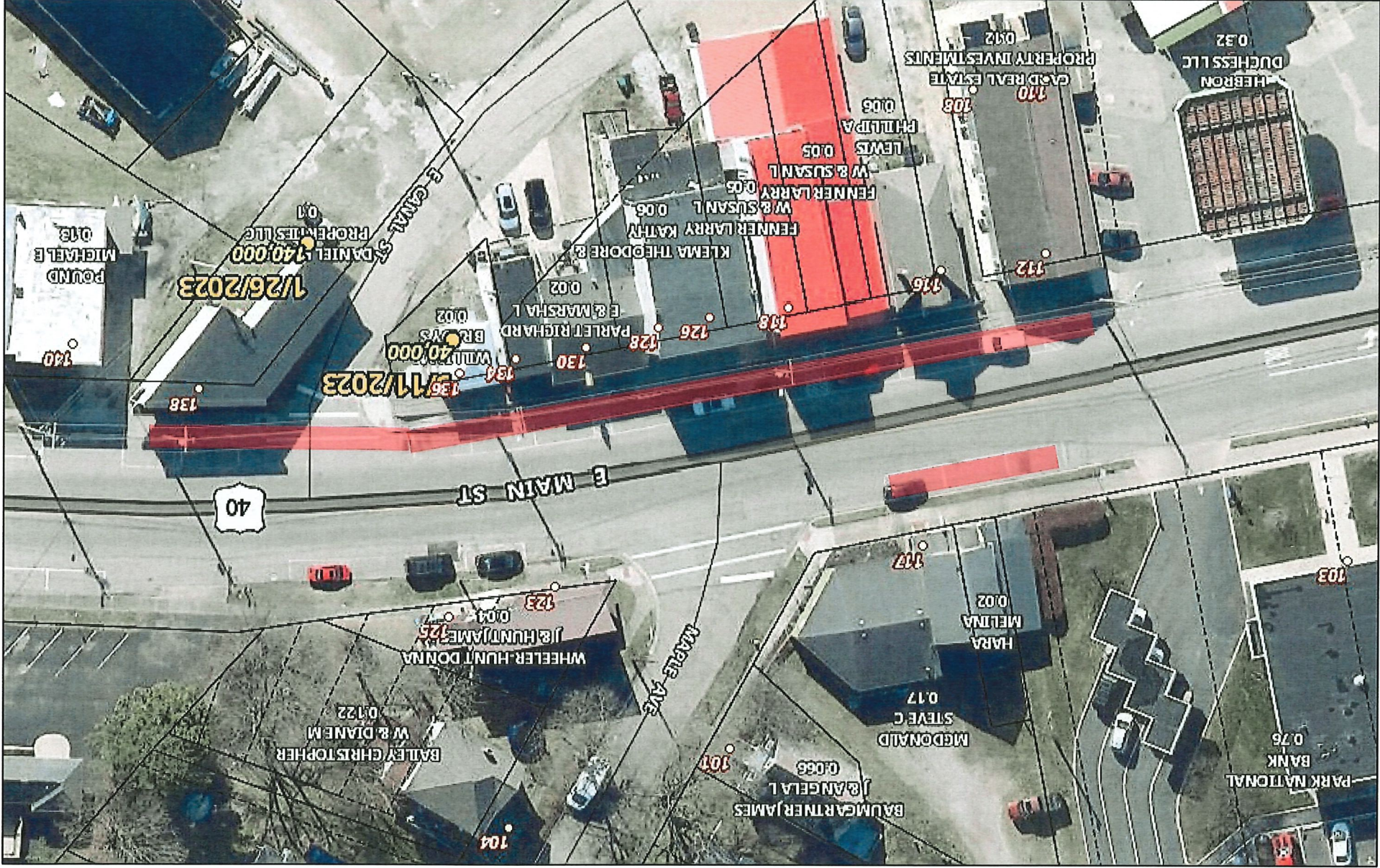
Chapter 351

Parking Generally

351.17 Establishment of a Two-Hour Maximum Parking Zone

- (a) In accordance with Ohio R.C. 4511.07(A)(1) there is hereby established a two-hour parking zone within the Village of Hebron commencing at the parking in front of buildings numbered 112 through 138 on the south side of East Main Street and buildings numbered 115-117 on the north side of East Main Street from the periods of 8:00am until 7:00pm Monday through Sunday.
- (b) In accordance with 351.17(a) any motor vehicle remaining within the zone designated as two hour parking in excess of two hours, regardless of if said vehicle moves to a different parking spot in the parking zone within this two hour time frame, shall be fined as set forth in the Fine Schedule enumerated in Section 303.99 pursuant to the guidelines of a minor misdemeanor classification for all offenses related thereto for the first offense.
- (c) In accordance with 351.17(a) any motor vehicle remaining within the zone designated as two hour parking in excess of two hours, regardless of if said vehicle moves to a different parking spot in the parking zone within this two hour time frame and within the previous six (6) months from the date of the current violation has been found guilty of or plead guilty to a violation Section 351.17, shall be fined as set forth in the Fine Schedule enumerated in Section 303.99 pursuant to the guidelines of a fourth (4th) degree misdemeanor classification for all offenses related thereto.
